iPOD APP - TREE LEAF RECOGNITION

Check this out.! FREE iPod app - leafsnap. It's a tree ID app using leaves. Take a picture of the leaf and a shape recognition algorithm takes over. "Leafsnap is the first in a series of electronic field guides being developed by researchers from Columbia University, the University of Maryland, and the Smithsonian Institution. This free mobile app uses visual recognition software to help identify tree species from photographs of their leaves. Leafsnap contains beautiful high-resolution images of leaves, flowers, fruit, petiole, seeds, and bark. Leafsnap currently includes the trees of the Northeast and will soon grow to include the trees of the entire continental United States."

Pruning Oaks and the Oak Wilt Infection Risk

To avoid above ground oak wilt infection, don't do any more oak pruning until fall.

I have received several calls from arborists asking if our cooler temperatures have prolonged the oak pruning season. The short answer is no, do not do any more pruning of oaks.

Here is a short explanation of the biology behind this. When oak trees are pruned, volatiles are released that are attractive to certain insects. Some of these beetles are vectors of the oak wilt pathogen (*Ceratocystis fagacearum*) and can carry spores to the pruning wounds. The pruning cuts can be entry points for the oak wilt fungus. Of course, pruning cuts do not heal instantaneously; research has shown that wounds can be infected for up to eight days after the pruning is done. Sapwood produced in the spring is also more susceptible to infection than that produced later in the season.

The months of April, May and June are considered the months with the highest risk for above ground oak wilt infection. The months of November to March are the safest time to prune oaks, when there is no to extremely little risk of oak wilt infection.

Side note from MSU Extension Forester and State Society Communications Chair Bill Cook:

Oak wilt occurs in both the LP and the UP. One more reason to not move firewood.

Prevention is the best treatment.

Oak wilt in infected oak stands cannot be removed by harvesting alone. Root systems must be isolated or removed (this is not cheap or always feasible). Residential trees and other high value individual trees can be protected with a fungicidal injection. Symptomatic oaks cannot be saved.

Michigan SAF Hosts U.S. Congressional Forestry Field Day



The Michigan SAF hosted a field tour and roundtable for U.S. Representative Dan Benishek, on June 8th in the central U.P. The Congressman's office requested two specific topics; 1) stream crossings that may be affected by the Ninth Circuit Court decision regarding forest roads and point source pollution permitting, and 2) a visit to a private, nonindustrial forest owner who has recently employed cost-share programs through the 2008 Farm Bill. The roundtable included a variety of forestry interests that put a range of concerns on the table for Rep. Benishek's consideration.

Field site one featured a recent culvert placement (picture on pg. 2) in a narrow wetland crossing to access a timber harvest on Plum Creek lands. The crossing did not require DEQ permitting but under

the Ninth Circuit Court ruling probably would. Charlie Becker estimated there would be hundreds of this type of crossing each year on Plum Creek lands alone. The group pointed out the successful role of Best Management Practices in already protecting water resources and that federal regulation of this sort of forestry activity would be beyond the current capacity of regulatory agencies as well as redundant. On the way out from the site, the group stopped at a county road stream crossing to point out how road construction techniques are used to minimize or eliminate runoff from forest roads.

The second site showcased several sites scheduled for reforestation under the 2008 Farm Bill. The upland hardwood sites were harvested 15-20 years ago and natural regeneration failed. Deer depredation was one regeneration failure issue. The forest owner wished to bring several parcels back into forest production and is currently participating in the Environmental Quality Incentives Program (EQIP).

Lunch and a roundtable discussion were held at the Sagola Township Hall. Members from forest industry, forestry consultants, and government agencies expressed a range of concerns for the benefit of Congressman Benishek. Topics included federals timber sale levels, wood energy, role of federal regulation, critical

role of healthy markets for healthy forests, forestry as a rural economic driver, and others.

The National SAF office provided a key role in helping to plan the tour and coordinate with Benishek's office. Assistant Director, Forest Policy, Kelsey Delaney participated in the tour.

REMEMBERING.....

Louis Joseph Verme

(January 24, 1924 - March 9, 2011)

Louis Joseph Verme passed away on March 9, 2011 in Rochester, NY after a brief illness. He was 87 years old.

Lou (formally Luciano) was born in New York City on January 24, 1924 to Sicilian immigrants Arcangelo and Vita (Costa) Verme. His family moved to a farm in Flemington, NJ when he was three years old, and it was there that he developed his love of hunting and the outdoors Shortly after graduating high school, Lou enlisted in the United States Marine Corps during World



War II. As a member of the Fourth Marine Division, he saw extensive action in the battle of Iwo Jima and was awarded the Purple Heart for injuries sustained during combat. After the war ended, Lou served as an MP for one year on the island of Okinawa, Japan.

Once home, Lou attended Michigan State University where he obtained a Bachelor's degree in Forestry in 1950 and a Master's degree in Wildlife Management in 1953. He was hired by the Michigan Department of Natural Resources as a wildlife biologist at the Cusino Wildlife Research Station in Shingleton, MI. Lou became biologist in charge at Cusino a few years later and he remained at this position until his retirement in 1988 after 36 years of service.

During his career, Lou was a noted and respected authority on whitetail deer. He authored over 70 scientific research articles and presented his work at many national and international wildlife conferences In addition, he received numerous awards for his work, including international recognition by The Wildlife Society for best research article of 1982. Lou also wrote and published the popular book Hiawatha's Brothers about the natural history and wildlife of Michigan's Upper Peninsula.

In 1957, Lou married Marquette, MI native Rose Marie Barr. They had two children, Ann Verme (Andy Martin) of Minneapolis, MN, and Thomas Verme (Nancy Ciavarri) of Rochester, NY. His beloved Rose Marie preceded Lou in death in 2008. Lou is also survived by his sister Rose Mazzucco of Middlesex, NJ, brother and sister-in-law Jack and Martha Verme of Potomac, MD, and sister-in-law Mary Ann (Barr) Wilmers of Gaylord, MI, as well as several nieces and nephews.

Lou loved bird hunting and continued to hunt through his 85th year. He also enjoyed Yankee baseball, Spartan basketball, Packer football, entertaining conversation, and a good martini. He and Rose Marie traveled extensively, including several trips to Europe as well as Australia, New Zealand, and Africa. Lou celebrated his 87th birthday this past January on safari in Tanzania with his son and daughter-in-law, at which time this photo of him was taken.

A memorial service was June 4, 2011 at Bowerman Funeral Home. In lieu of flowers, memorials preferred to The Nature Conservancy, P.O. Box 6014, Albert Lea, MN 56007. On the memorial check, please reference: Memorial tribute to Louis J. Verme, account 11013236, zip code 49862.
