The Michigan Tech answer: drainage basin. The officials huddled to determine if the answer is correct; it wasn't what they expected. The ruling on the field, INCORRECT, and Minnesota steals the victory based on bad officiating. The officials' correct answer was "watershed." Unfortunately, the poorly trained officials did not know the entire definition of watershed. The Dictionary of Forestry, online at the SAF website, lists drainage basin as a synonym for watershed. Once again, Midwesterners are subjected to bad officiating in the State of Washington.

Obituary ~

Robert S. Manthy

Robert S. Manthy, age 73, of Lansing, MI, passed away November 11, 2012. He was born April 4, 1939, in Chicago, IL. He is survived by his wife, Carol A. Manthy; son, Robert S. Manthy, Jr.; daughter, Jill Manthy Langosch; and 8 grandchildren, Vincent, Jillian, Blue, Samuel, Mary, Roxanne, Catherine and James.

Dr. Manthy was Professor Emeritus upon his retirement from Michigan State University in 1997. He received his Bachelor's degree in forestry and Master's and Ph.D. in forest economics from Michigan State University. The late Dr. Lee M. James guided his graduate studies. After a short stint as an economist with the U.S. Forest Service's Northeastern Forest Experiment Station in Upper Darby, PA, he returned to his alma mater. He joined the Department of Forestry in 1966 as an assistant professor and achieved the rank of professor in 1975.

He was an accomplished, energetic teacher and researcher. His teaching and research focused on forest economics and natural resource policy. An important thrust of his research was on economic scarcity of natural resources; his quantitative research in this area contributed to the national debate on our ability to use technology and substitution to overcome scarcity. He was a sought-after speaker for national events focused on forest policy. He was also a founder of Greentree Consultants, a successful consulting firm. Many of his graduate students went on to leadership roles within the U.S. Forest Service and elsewhere.

Per his wish cremation has taken place and no service will be held. In lieu of flowers, memorial contributions may be made to Sparrow Hospice (www.sparrow.org/Hospice).

New state initiative offers private forest landowners assistance, information in managing their lands

The Michigan Department of Agriculture and Rural Development (MDARD), the Michigan Department of Natural Resources (DNR) and local conservation districts have partnered on a new initiative – the Forestry Assistance Program – designed to increase active management of non-industrial private forest lands (private forestland owned by individuals).

The goal of this collaboration – bringing together landowners, conservation districts and private forestry consultants – is to boost the sustainable management of Michigan's private forest lands. Such collaboration will naturally help to foster the growth of the timber products industry in Michigan.

"Michigan is rich in forest resources managed by private ownership," said Jamie Clover Adams, MDARD director. "This partnership will further cultivate the relationships between state government, conservation districts, private landowners and private consulting foresters in the management of these untapped lands to increase the growth of timber products."

There are currently 11 million acres of non-industrial private forest land in Michigan. A survey (conducted by Michigan State University) of those private forest landowners concluded that only 20 percent of that 11 million acre resource is currently being actively managed for specific forestry outcomes.

Thirteen local conservation district foresters in 31 counties will provide on-site technical assistance to assess forest land quality and potential. Next, the foresters will work with landowners to identify their forest objectives for their land. Working through an established local network of private consultants, agency staff, industry representatives, timber buyers and conservation organizations, the conservation district foresters and landowners will plan a course of action to best meet those objectives. SAF's Role in Policy Formulation and a Summary of the SAF Policy Process

The <u>SAF national office</u> established a formal natural resource policy program in 1971. Subsequent appointment of a full-time policy director reflected the profession's commitment to actively participate in developing policies regarding the country's renewable natural resources. According to Bylaw II-C, a forestry issue is "a matter relating to forestry, the resolution of which is of public importance." The forest policy department at the national office works closely with members in the formulation of both national and local position statements and in other resource policy activities regarding forestry issues.

SAF does not make natural resource policy. Instead, the Society participates in the political and administrative processes that generate policy by presenting our views to policymakers. These views — <u>SAF position statements</u> — are developed using a position taking process that is detailed in the <u>SAF Bylaws</u>.

SAF influences policy through the consistent development of high quality, science based positions on issues affecting renewable natural resources and their management. SAF's position is the professional view.

<u>National Positions</u> provide society with the professional view on a specific natural resource issue, and must be approved by at least two-thirds of the SAF Council (normally for a five-year period). Currently, there are 19 National Position Statements covering topics such as biodiversity, clearcutting, fire, roads and private forest management.

<u>Unit Positions</u> are formulated by state societies, divisions, or chapters, and are adopted by at least two-thirds of the unit's executive committee. The national office reviews all draft position statements to ensure their consistency with national position statements and <u>Forest Policy Principles</u>. The Society's forest policy principles, approved by referendum, guide the positions the Society takes in contributing its professional knowledge to public deliberation on forestry issues. Currently, MSAF has no active Position Statements - one Statement on Non-Industrial Private Forests expired on January 29th, 2012 and another on Fire Management expired on May 30th, 2012. We also have an expired Statement on White Tailed Deer.

The expiration of these policies has not caused an uproar from our members, which leads me to ask: "Are they still needed"?

The Non-Industrial Private Forests Position states that the Michigan Society of American Foresters encourages the expansion of programs to help retain private forestlands and improve the management of these lands. To accomplish this, the ... organizations [in Michigan] should agree on a set of principles and goals for NIPF programs and their respective roles and responsibilities in implementing these agreements.

The Fire Management statement supports stable and adequate funding for wildfire suppression and ongoing training in fire management agencies and local fire departments. Programs that educate landowners and local governments of the danger of wildfire and methods for minimizing risk also are sorely needed, as are fuel reduction programs. Michigan SAF also supports the use of prescribed fire under proper weather and fuel conditions to achieve clearly defined land management objectives. A cadre of highly trained and experienced personnel is essential for proper implementation of prescribed fire, and Michigan SAF advocates recurring training of personnel in agencies and organizations doing prescribed burning.

On white tailed deer, the Michigan Society of American Foresters advocates the sustainable use and management of all Michigan forest resources for the good of society. To do this, white-tailed deer (Odocoileus virginianus) populations must be low enough to allow for the regeneration of forests and the development of desired plant communities and wildlife habitats.

Forester Safety and Logging Operations

Safety in and around logging jobs can never be over emphasized within the forestry profession. Most of us, throughout our career, inspect timber sales on a regular basis. While accidents rarely happen most of us have had a close call or a "dent in the fender" to prove otherwise. Upon inspecting an active timber sale in late October, I found it odd to see a badly damaged log truck at a landing with a damaged radiator, cowling and broken windshield. With moose/vehicle accidents being a rarity in the Eastern UP, I had to ask the logging crew what had happened. The crew explained that the skidder operator was on the landing and while sorting out numerous species of product would move a few chains here and there to the respective piles. Little did the operator know that while he was unloading, a log truck had arrived on the job and parked approximately 100 feet behind him. With his fully loaded skidder the operator moved in reverse which only provided a clear view to the sides of his machine and not the log truck directly in harms way. The skidder operator explained that even once he had hit the log truck he was not aware of the problem and stated that if the vehicle would have been a pickup he would of likely went over the top of it. It goes without saying that we all need to be aware of our surroundings while on active timber sales and pick safe areas to park while doing sale inspections. When working near equipment never assume an operator knows you are present until you have made eye contact with them and keep a safe distance at all times. A few added steps of precaution can go along way in terms of forester safety in and around logging operations. Stay safe out there!
