OLD BUSINESS: Auto Tour

Glen Moll informed the group on the Auto Tour Brochure, its printing and editing. Glen mentioned that Joyce Angel-ling did much or most of the work in coordinating and overseeing that the signs were getting out in the field. There were some changes made in editing this year, 49,000 brochures were printed. This was more than the previous year because of additional sites, lower costs for printing, greater quantity as well as additional monetary support from SFI - \$8,700.00, S.A.F. - \$1,000.00 (\$500.00 from state, \$500.00 from U.P. Chapter) and \$700.00 from the Tree Farm.

Ken Salo wanted to thank the Committee for the excellent work in putting this endeavor together and accomplishing the task. Ken also expressed his concern over the continuing expenses that will occur in keeping this project over time. He mentioned Superior Press had expressed the possibility of printing the brochure for no charge, if they can go out and raise the funds for printing by advertising through soliciting and keep those funds. There would need to be more time and discussion on this in the future.

It was expressed if you see signs along the road that get damaged, take the initiative to get the sign repaired for they are our signs out in Public view. Our appearance will need to be maintained by all members.

Sub-Chapter Chair vacancies occur at Marquette and at Gogebic/Iron/Ontonagon group. Any one interested in chairing should call Ken Salo.

There was no report on the Awards at this time.

A new MI SAF Display is needed, for the last one seems to have gotten lost. Glen Moll and Bob Ilyde need ideas on this as they were working on the development of one. It should be professional in appearance, neat, and durable.
